

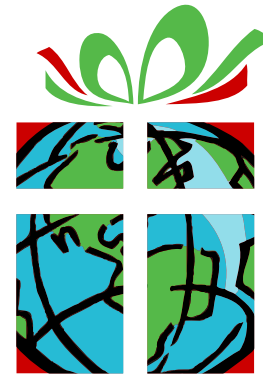

**PURPOSE:** (1) Raise funds to support local and global outreach mission projects and organizations; (2) create a unique holiday shopping experience for the church and community; and (3) provide a venue for individual vendors and groups to sell their wares. We want to offer a variety of products that are fresh, appealing and appropriate for the Christian market.

**ELIGIBILITY:** Members of Trinity will have the first opportunity for submitting a vendor application. After July 1, outside vendors may submit application for consideration. ALL vendor applications will be reviewed by the AGAPE Gift Market team for approval. Our goal is for the market to include a variety of quality products available for sale. We want to minimize duplication of products to assure the success of each vendor participating in the market. Due to the limited vendor space, previous vendor donation values will also be used to determine 2026 market participation.

**AUDIENCE:** Our target audience includes Trinity Lutheran Church members and the surrounding community.

**DISPLAY:** The market will take place in Trinity's Great Hall (gym).

**DONATION:** At the conclusion of the market, vendors will submit a summary of their sales along with a payment of 20% of their total sales. There is no individual table fee.

**GUIDELINES:**

1. ALL vendors of the AGAPE Gift Market must submit images of the items you will be selling. Please provide in a digital format (may be used for publicity).
2. By Sept 15, 2026, complete and return both sides of this vendor

application or apply online.

3. Each vendor will be provided with either an 8- or 6-foot table for merchandise display. Vendors must supply their own table covering. If electricity is needed, please indicate on form.
4. Each vendor must be present during the hours of AGAPE Gift Market and is responsible for handling their sales transactions.
5. Each vendor must supply a current valid State Sales Permit prior to the Agape Gift Market.
6. We will promote this market extensively through our church publications, website and social media, in the community, print media, community calendars, ads in local publications, news releases to print and broadcast media.
7. Vendors will be able to set up their table on Friday, November 13th (Noon-5pm) OR Saturday, November 14th (8-9am). All vendors must be ready by 9am on Saturday morning.
8. All vendors will be asked to help promote this event. We will email flyers that you can use for distribution and encourage you to promote via social media.

- November 14 & 15** – AGAPE Gift Market expected hours Saturday 9am-4pm, Sunday 9:30am-1pm
